## **Resort Reservations & Our Policy**

We are pleased you've decided to be our guests this year in one of our Minnesota lake cabins. Because our reservations change rapidly **you must phone in your reservation** prior to sending in this form to **Lakewood Lodge**, **53026 County Road 35**, **Deer River, MN 56636**. We will hold a cabin for 6 days to allow the reservation form and monies to be mailed in. If the form and deposit is not received in that time, your reservation will be automatically cancelled.

Reservations will not be confirmed until we receive a completed and signed reservation form and all deposits due. A payment of deposit is considered acceptance of the reservation and cancellation policies. We will e-mail or mail a confirmation to you once all the required information is received. All persons staying in the cabin must be listed on the reservation form and you must be 21 years old and have a valid credit card to reserve a cabin. Thank you.

**Deposits/ Cancellation Policy** Spring/Summer/Fall Deposits: Deposits are \$150 per bedroom. We understand that from time to time you must cancel your vacation for various reasons. Please understand that your **Spring/Summer/ Fall Deposits** are non-refundable however we will apply the deposit to another reservation within the same calendar year of equal value to the original reservation (subject to availability). You are responsible for the entire length of your reservation for cabin(s) and boat(s). No credit will be given for late arrivals or early departures. Please email or call us with any questions.

Winter Deposits are 25% of the reservation and are due January 1st. Winter deposits are non-refundable and non-transferable once confirmation of reservation is made.

If you must cancel your reservation we will do our best to re-book it. You are responsible for all remaining balances of your reservation until all cabins for the week reserved are filled. We strongly recommend you consider "trip insurance" for any unforeseen reason you may need to cancel your reservation. It may reimburse you for your non-refundable payments and/or deposits.

**Credit Card Information Policy** You must provide a credit card number even if you are paying via check or money order. Include your credit card number on the reservation form. Lakewood Lodge must have this information in order to confirm a reservation, and the credit card must be in the name of the person making the reservation. Your submission of a reservation form signifies your agreement to abide by all of our reservation policies and serves as your signature on all credit card processing receipts for deposits and payments due. All pricing is a cash price only. Please add 2% if paying by credit or debit card.

**Pet Policy** No animals are allowed except for Hunting Dogs during Minnesota Duck/Grouse Hunting Seasons only. Dogs are NOT allowed in the cabins at any time. ALL dogs must have prior approval. If you would like to bring a dog, it must have proof of all shots, be flea-free, must be leashed or chained up and must be cleaned up after. We require a \$200 refundable pet deposit (deposit is refunded following inspection of resort grounds after checkout). You are financially responsible for any damages caused by your pet.

Check-In AFTER 3pm and Check-Out BY 8:30am Please respect these times so that we can properly clean all cabins, boats and have the resort properly maintained and ready. No early arrivals or late departures. No Exceptions! Please notify us if you will be arriving after lodge hours.

- A dock space with electricity for your boat is included with each cabin rental. Please reserve in advance, our dock spaces are on a first come first served basis.
- Bring your own towels and soaps all other linens are provided.
- Please request linens for futons on your reservation form.
- Please request cribs or high chairs on your reservation form.
- No ATV's allowed on resort grounds without pre-approval.
- No Jet Skis or Wave Runners allowed without pre-approval.
- No Smoking in any of Lakewood Lodge cabins or lodge. You may smoke outside or in the screen porch with windows and doors closed.
